

Privacy Notice (How we use school workforce information) The categories of school information that we collect, process, hold and share include:

- personal information (such as name, employee or teacher number, national insurance number)
- special categories of data including characteristics information such as gender, age, ethnic group
- contract information (such as start dates, hours worked, post, roles and salary information)
- work absence information (such as number of absences and reasons)
- qualifications (and, where relevant, subjects taught)
- documentation required to support safeguarding (such as Single Central Register information including right to work in the UK documentation, DBS number, references and staff suitability declaration)
- warnings /disciplinary information (such as management warning letters)
- training information (such as courses attended)
- relevant medical information when provided by the workforce
- payroll information (such as payroll number)
- photographs
- Right to Work information

Why we collect and use workforce information

We use school workforce data to:

- enable the development of a comprehensive picture of the workforce and how it is deployed
- inform the development of recruitment and retention policies
- enable individuals to be paid
- safeguard pupils and staff
- to facilitate the education of our pupils

Under the UK General Data Protection Regulation (UK GDPR), the legal basis / bases we rely on for processing personal information for general purposes are:



Article 6

- 1. Processing shall be lawful only if and to the extent that at least one of the following applies:
- (c) Processing is necessary for compliance with a legal obligation to which the controller is subject;

In addition, concerning any special category data:

Article 9

- Processing of personal data revealing racial or ethnic origin, political opinions, religious or philosophical beliefs, or trade union membership, and the processing of genetic data, biometric data for the purpose of uniquely identifying a natural person, data concerning health or data concerning a natural person's sex life or sexual orientation shall be prohibited.
- 2. Paragraph 1 shall not apply if one of the following applies:
 - (j) Processing is necessary for archiving purposes in the public interest, scientific or historical research purposes or statistical purposes in accordance with Article 89(1) based on Union or Member State law which shall be proportionate to the aim pursued, respect the essence of the right to data protection and provide for suitable and specific measures to safeguard the fundamental rights and the interests of the data subject.

Education Act 2005 sections 113 and 114 - is a statutory requirement on schools and local authorities for the submission of the school workforce census return, including a set of individual staff records,



Collecting workforce information

Workforce data is essential for the schools / local authority's operational use. Whilst the majority of personal information you provide to us is mandatory, some of it is requested on a voluntary basis. In order to comply with UK GDPR, we will inform you at the point of collection, whether you are required to provide certain information to us or if you have a choice in this.

Storing this information

We hold data securely for the set amount of time as outlined for the period of time as outlined in retention schedule taken from the Information Management Toolkit for Schools Version 5 (01st February 2016)

Who we share this information with

We routinely share this information with:

- our local authority
- the Department for Education (DfE)
- future employers as part of a requested reference

Why we share school workforce information

We do not share information about workforce members with anyone without consent unless the law and our policies allow us to do so.

Local authority

We are required to share information about our workforce members with our local authority (LA) under section 5 of the Education (Supply of Information about the School Workforce) (England) Regulations 2007 and amendments.

Department for Education (DfE)

The Department for Education (DfE) collects personal data from educational settings and local authorities via various statutory data collections. We are required to share information about our children and young people with the Department for Education (DfE) for the purpose of those data collections.

We are required to share information about our school employees with our local authority (LA) and the Department for Education (DfE) under section 5 of the Education (Supply of Information about the School Workforce) (England) Regulations 2007 and amendments.

Data collection requirements

The DfE collects and processes personal data relating to those employed by schools (including Multi Academy Trusts) and local authorities that work in state funded schools (including all maintained schools, all academies and free schools and all special schools including Pupil Referral Units and Alternative Provision). All state funded schools are



required to make a census submission because it is a statutory return under sections 113 and 114 of the Education Act 2005

Requesting access to your personal data

- not to be subject to decisions based purely on automated processing where it produces a legal or similarly significant effect on you.

The workforce data that we lawfully share with the Department for Education (DfE) through data collections:

- informs the Department for Education (DfE) policy on pay and the monitoring of the effectiveness and diversity of the school workforce
- links to school funding and expenditure
- supports 'longer term' research and monitoring of educational policy

Under the terms of the Data Protection Act 2018, you're entitled to ask the Department for Education (DfE):

- for a copy of your personal data and any details of its source
